I lost my breasts in cancer in 2005 while working full time on sets. i worked my tush off also taking classes on line at SMC in web bc I wanted to work on sets and in production- I will never be happy again until I am walking on a studio but as an actress. I do not have a job. I showed up tot he set of Grays just 8 months after I was tripped on a set- and I worked my tush off to walk and run again after a car accident in 1997. It took me 8 years to get to the poitn I could run if someone were chasing me. I was told I could never work on ABC lots again and I was being assaulted by a man named Jeremy Gilbreathe who was fired from

Carnivale for drugs. Your wife is a lawyer- ask her this- why a woman with good credit, who ever stold anything, or interrupted production or was excessivly late or broke the law- would be told to come to set and then to be told she was on a list. I am in debt from law school and fighting to find a way to pay that off without giving up a career acting. ACTING IS THE ONLY REASON I CHOSE TO LIVE WITHOUT MY BREASTS. I worked for 5 years for central and made 23,000 a year. I loved my life and I do nto want a husband or men in my life unless I know I can stand on my own two feet and make a livign acting. Period.

Central acted like I had never worked a day. All of a sudden five years of my life were gone. I did nothign wrong. I did not lave los angeles. I had no reason to leave bc having had the cancer I would rather die than spend a day at any job I did not love just to pay my bills and make money. I can not feel my toes on one foot and I am scared my cancer is back. I hate Patrick Dempsey. I never woult hurt anyone. But Johnny Ponzios ex girlfriend was the stand in On Gray's and she was abusing me and then I get treated like a terrorist. I had good credit and there was no reason for me to be treated like that or anyone. Unlessl know I have a future on sets- I have nothing to work for no matter how much debt I may be in. I am looking at being miserable for the rest of my life and I did nothing wrong.
